- 2.5 ufinyelele encazelweni yemisebenzi ekhona yamalungu omphakathi etholakala e-AGSA, kanye nendlela yokufinyelela kuleyo misebenzi;
- 2.6 uqonde indlela yokusebenzisa i-Paia, njengoba ibuyekwezwe wuMlawuli kanye nendlela yokutholakala kwayo;
- 2.7 wazi ukuthi ingabe i-AGSA izolulungisa na ulwazi lomuntu siqu;
- 2.8 uqonde inhloso yokuba i-AGSA ilungise ulwazi lomuntu siqu, kanye nencazelo yezigaba zabanikazi bemininingwane kanye nolwazi noma izinhlobo zolwazi oluqondene nazo;
- 2.9 wazi abamukeli noma izigaba zabamukeli abangahlinzekelwa ngolwazi lomuntu siqu;
- 2.10 wazi ukuthi ingabe i-AGSA ihlele ukudlulisa noma ukulungisa ulwazi lomuntu siqu ngaphandle kweRiphabhulikhi yaseNingizimu Afrika; futhi
- 2.11 wazi ukuthi ingabe i-AGSA inazo na izindlela zokuvikela ezimisiwe zokuqinisekisa ubumfihlo, ubuqotho kanye nokutholakala koLwazi Lomuntu Siqu oluzolungiswa.

3. UKUSUNGULWA KOMCWANINGIMABHUKU-JIKELELE WASENINGIZIMU AFRIKA

Isahluko 9 soMthethosisekelo weRiphabhulikhi yaseNingizimu Afrika, 1996 (uMthethosisekelo) usungula uMcwaningimabhuku-jikelele njengesinye sezikhungo zikahulumeni ezisekela intandoyeningi ngokomthethosisekelo. UMthethosisekelo ugcizelela ukuzimela kwethu ngokukhipha umyalelo wokuthi sihlonipha uMthethosisekelo noMthetho kuphela. UMthethosisekelo udinga ukuthi i-AGSA ingachemi futhi isebenzise



amandla ayo futhi yenze imisebenzi yayo ngaphandle kokwesaba, ukuchema noma ukulimaza.

Isigaba 188 (1) soMthethosisekelo, sifundwa nesigaba 4(1) soMthetho Kahulumeni 25 wezi-2004 (i-PAA), ibeka umthwalo othile ku-AGSA, okungukucwaninga nokubika ngama-akhawunti, izitatimende zezimali nokuphathwa kwezimali maqondana:

- nezikhungo ezimiswe ngokomthethosisekelo;
- nokuphathwa kwePhalamende nesishayamthetho sesifundazwe ngasinye;
