The Auditor-General of South Africa (AGSA) is the supreme audit institution (SAI) of the country. As SAI South Africa, a constitutional mandate to support our country's democracy through auditing is enshrined in our existence. To achieve this goal and to respond to our environment, we set out in 2017 to improve our audit methodology. This was brought about by a change in audit standards as well as a need to change our methodology to an integrated approach, thereby elevating risks that form part of the audit process to allow us to produce a more relevant audit product.

these. This we do through gaining an understanding of the auditee and conducting a detailed risk assessment. This process then helps guide the audit team to determine the required resources for an audit. The makeup of our teams has evolved from including only regularity auditors, to including investigators, performance auditors, information systems auditors as well as a range of subject matter experts. They are deployed to the audit based on the assessment process and the auditee's field of practice.

This investment has resulted in an in-depth analysis of our auditees, which we include in our consolidated general reports. Apart from these reports, we make use of management reports (an audit communication document between an auditee and an auditor) to share valuable insights with our auditees and the accounting executive.

#### **Database of experts**

Through our performance audit and our corporate legal and provisioning services business units, we are the custodians of a comprehensive database of subject matter experts. We use the database to source the skills of qualified and experienced professionals to assist us during our audits.

#### Blending our methodology
