## **Umcwaningimabhuku jikelele ukiphe imiphumela yocwaningomabhuku lomasipala ngaphansi kwesiqubulo esithi - "ayizanele izidingo, kube zingakabibikho izandla ezifanele esisefweni semali"**

**EPITOLI** - namuhla uMcwaningimabhuku-jikelele (u-AG) uKim Makwetu ukiphe imiphumela yocwaningomabhuku lohulumeni basekhaya yonyaka wezi-2018-19. Lo mbiko uwunike isihloko esithi Ayizanele izidingo, kube zingakabibikho izandla ezifanele esisefweni semali ezizoveza isimo sokupathwa kwemali kohulumeni basekhaya.

Embikweni owujikelele wohulumeni basekhaya, u-AG udwebe isithombe esingathandeki ngezigidigidi zamarandi emali eyabelwe omasipala abaphethwe "ngezindela eziphambene nezimiso ezilotshiwe nezamukelekile zokubala". Uxwayisa kakhulu ngokuthi leli gebe elikhona kwezokupathwa kwemisebenzi nezokubusa "lidala ukuthi kube nokuntengantenga okukhulu kwezesibophokubika kanye nokuba semathuben ikuhlangabezana nokusetshenziswa ngokungafanele kwesikhwama sikahulumeni".

Lo ngumbiko kaMakwetu wocwaningomabhuku lomasipala wokugcina njengoba ihlandla lakhe lemnyaka eyisikhombisa njengo-AG wezwe liphela mhla zingama-30 Novemba 2020.

Embikweni uMakwetu wenaba ngesiqubulo salo mbiko. Uchaza ukuthi imisebenzi iyenziwa futhi amakhasimende ayayithola impahla kubo bonke omasipala kube kulindeleke ukuthi bazoyikhokhelwa. Kepha kunomkhuba obonakale uvama wamabhizinisi amakhulu kuwo wonke lo mkhakha aveze izimpawu zokwehla kwezinga lokukhokhela le msebenzi, noma anqaba ngokuphelele ukukhokha.

abantu nemizi nabo babhekene nencindezi efanayo futhi abayikhokheli impahla abayitholile nemisebenzi abahlinzekwe ngayo. Ukubonisa ukuvama nokusabalala kwalo mkhuba kuleli zwe, ilinganiselwa kuma-60% ingeniso ebonakala emabhukwini engasoze yangena kuma-akhawunti asebhange kamaspala. Ama-akhawunti abalwe kulo mbiko abandakanya ububanzi bale nkinga. Uhlelo olusetshenziswayo aluphumelelanga ekuguquleni isikweletu sibe yimali eminyakeni eyinqwaba edlule, njengoba kubonakele eminyakeni yesikweletu. Nokho, lokhu akusho ukuthi kungama ukulandelelwa kwale mali.

Kusenjalo, labo abenzela umasipala umsebenzi noma abahlinzeka ngemisebenzi yezokuphatha kanye neminye imisebenzi bayaqhubeka nokuthola imiholo yabo, eningi nokucishe kube yiyona kuphela kwezinye izimo, evela emholweni othathwe esikhwameni sikazwelonke. Lesi simo sezimali somaspala sidalwa wukuthi akusibo bonke abayingxenyeyalabo abaholelwayo abafakwa ngenhoso yokuhlinzeka ngqo ngemisebenzi eyingxenyeyezinhlelo zikamasipala. Lokhu kushiya umasipala ungenakho okuningi ongakwenza ngaphandle kokufuna usizo lwangaphandle - nasemikhakheni osekunabantu abaqashiwe kuyo abakhona. Lokhu kubiza imali enkulu ekhokhelwa ochwephesh. Umphumela ovamile walokhu wukuthi labo abahlinzeka ngempahla nemisebenzi bethenjiswe ukuthi bazokhokhelwa ngomuso kumele balinde kuze kwabiwe imali entsha okumele isetshenziswe ngomuso ngaphambi kokuba bakhokhelwe ngemisebenzi

abayihlinzeka ngokudlule. Umphumela ogcine uvelile ngalokhu uholela kwangqingetshe ngokwezimali obekungeke kugwemeke njengoba sewufinyelele kwiningi lomasipala bendawo nabezifunda ezweni lonke, ngaphandle kwezindawo ezimbalwa.

Empeleni, yikho lokhu okuveza ukwahlukana kwemiphumela yocwaningomabhuku lwezitatimende zezimali zohulumeni basekhaya ezweni lonke. UMakwetu uqaphele ukuthi kumele kubalulwe ukuthi bakhona abenza ngendlela ehlukile - isibalo esikhulu esiseNtshonalanga Kapa (yize kunezindawo ezibonakele ezikhathazayo ezifundeni i-Karoo naku-Garden Route kulesi sifundazwe).

Uma sekucutshungulwe iziphetho zocwaningomabhuku ezahlukene kulo mbiko, kumele kuhlalwe kukhunjulwa okubalwe ngenhla. Akusekho mayelana nokusheshisa umfutho wokufinyelela esiphethweni socwaningomabhuku esithile, kodwa ukuthi umasipala ufaka utshalomali ezindleleni zokucubungula nezokuvikela ukuze kugwemeke lokhu kwehla kohlelo kwezezimali emkhakheni lapho konke kunesidingo kuwo. UMakwetu uxwayisa ngokuthi ukubaluleka kwalo mbiko akumele kube mayelana nokuhlakanipha, ukucutshungulisiswa kwezinhlelo lapho kunomcabango ongaba yingozi wokubuka indlela ngezindlela ezahlukene ukuze kuncishiswe umonakalo noma ukuchezuka isuka ezinkingeni ezinkulu. Kunalokho kumele kube mayelana nokuthi "izinyathelo ezingala zizosetshenziswa kanjani ukubuyisela ubuqotho balezi zikhungo futhi zibekwe esimweni sokuba zikwazi ukuphatha imali yazo ngendlela eziphumelisa izidingo zezakhamizi".

Selokhu angena esikhundleni sokuba yinhloko yesikhungo esiphezulu kunazo zonke ezweni ngowezi-2013, uMakwetu ube lokhu eme kwelokuthi labo abanomsebenzi wokuphathwa kwemisebenzi nokuqapha kumele babheke izinhlelo eziyisisekelo nezilawuli njengalokho okuyisisekelo sokuzibophezela

ezakhamizini zezwe, ukuze kuqinisekiswe ukuthi izimali zabakhokhintela zisetshenziswa ngendlela efanele ngokuhambisana nokubhalwe emithethweni eminingi elawula ukusebenza ngokufanele komasipala nokuthi izakhamizi zithole izinzozo ezilindelekile ngokusetshenziswa kwale mali.

Nokho, kulo mbiko wokugcina kahulumeni wasekhaya, u-AG usitshela indaba engemnandi yokuthi omasipala abaningi "ngabakhutshazwe yisikweletu futhi abangakwazi ukukhokhela amanzi nogesi; abaqoqa ingeniso ngendlela engaqondile nengakhuthazi; ukusetshenziswa kwemali okungagunyazwanga, okungafanele, okungenanzozo nokuwukusaphaza; kanye nokwethembela kakhulu ezbonelelweni nasosizweni oluvela kuhulumeni kazwelonke.

### **Omasipala abambalwa abasebenza ngendlela eveza indaba ethakaselekayo**

UMakwetu wazisa imizamo yalabo masipala abasebenze kanzima ukuqinisekisa ukuthi abatholi futhi bayaqhube ka nokuba nocwaningomabhuku olungenasici, baphinde baxoxe indaba enhle ngezindlela abaphethe ngazo omasipala babo.

Uphawule wathi, "Izitatimende zezimali zikamasipala zixoxa indaba yokuthi umasipala uphethwe kahle kanjani. Njengoba kwenzeka kulabo masipala abambalwa, kungaba yindaba enhle yokusebenzia imali ngokufanele okwenza imali yenze okufanele; izinqubo ezincomekayo zokubasa nokuqoqa imali; impahla enakekelwayo nevikelwayo; utshalomali nokonga okwenziwa ngokucophelela kwezimo eziphuthumayo nemisebenzi yangomuso; kanye nokuzibophezelwa kwabakweletayo kanye nokuhlonishwa komphakathi."

Omasipala abayishumi nantathu kulabo bebeseNtshonalanga Kapa futhi babandakanya omasipala besifunda base-Cape Winelands nase-West Coast, e-Bergrivier, e-Cape Agulhas, e-Cederberg, e-Drakenstein, e-Hessequa, e-Langeberg, e-Overstrand, e-Prince Albert, e-Saldanha Bay, e-Theewaterskloof nase-Witzenberg. Abanye omasipala abaqhubekile nokusebenza kahle kube

iSenqu (eMpumalanga Kapa), e-Midvaal (eGauteng), Okhahlamba (KwaZulu-Natali), umasipala wesifunda wase-Capricorn (eLimpopo), omasipala besifunda base-Gert Sibanda naseNkangala (eMpumalanga), nomasipala wesifunda wase-John Taolo Gaetsewe (eNyakatho Kapa).

Izinqubo zokusebenza ngempumelelo zalabo masipala bezibandakanya ubuholi obunozinzo obuzinikele ngokulawula ngokuqinisa isandla nokuphatha okunempumelelo. Ukuqhubeka nokuqapha izinhlelo zocwaningomabhuku zabo ukuze babhekane nanoma emiphi imiphumela yocwaningomabhuku ngesikhathi kanye nendlela yokuthatha izinyathelo kuqala ekubhekaneni nengcuphe equbukayo nakho kube yinqubo etholakele kulabo masipala.

Umbiko wezi-2018-19 uxoxa indaba yokuthi izinhlelo zalabo masipala abaphuma phambili zembozwe wukwehla kwemiphumela yocwaningomabhuku isiyonke.







## A. Izindaba ezivele ezifundazweni

Isifinyezo esingezansi sixoxa indaba yokuthi izifundazwe ezahlukene, ngokulandelana ngokwe-alfabhethi, zisebenze kanjani onyakeni obuyekezwayo.

### IMpumalanga Kapa

Umbiko ka-AG uxoxa indaba yokuvama kokusilela kwezindlela zokulawula imali nokuqapha imisebenzi, usiko oluqhube kayo lokusilela kwesibophokubika kanye nokwamukela ukuphulwa kwemithetho, okudale ukuqhube ka kokwehla kwemiphumela yocwaningomabhuku ezifundazweni - ukuthuthuka kube mbalwa futhi umphumela obonakele eminyakeni emithathu uqhubekile nokuba mubi. Omasipala abayisishiyagalombili abakwazanga ukweseka ngokwanele ulwazi olubikwe ezitatemendeni zezimali zabo base bethola imibono engenamphumela.

Kunokuba kuphathwe ngokunakekela nangokufanele imali eqondene nezinsiza ezishodayo, kube nezimo zokulawula ebezingasebenzi ngokufanele; ukungahleleki okukhulu kumarekhodi ezokubala; ukungavalwa kwezikhala zemisebenzi ezisemqoka okudonse isikhathi eside kanye nokungabibikho kozinzo emikhandlwini; izinqubo zokuthenga ezintengantengayo; ukungabibikho kokujeziswa ngokusebenza ngendlela engagculisi kanye nokuphulwa kwemithetho; kanye nokubika ngezimali nezinhlelo zikamasipala ngendlela engenakho ukwethembeka.

Umbiko uveza ukusetshenziswa okungajwayelekile kwezigidigidi ezingu-R2,5 ngonyaka obuyekezwayo. Kube kunezinye izigidigidi ezingu-R4,2 ezavezwa ocwaningweni olwaqedwa kulandela usuku olwaluwumqamulajuqu walo mbiko.


Isifundazwe sasebenzisa izigidi eziyi-R118 ngezindleko zokwelulekwa wochwepheshe maqondana nokubika ngezezimali. Kulokhu, izigidi ezi-R2 zasetshenziswa omasipala okwakungakaqedwa ucwaningomabhuku lwazo ngosuku olwaluwunqamulajuqu walo mbiko.

## E-Free State

Imiphumela yocwaningomabhuku esifundazweni iqhubelele nokwehla onyakeni wesithathu ilandelana. Omasipala abayishumi abazange bazithumele izitatinende ngesikhathi - okube ngaphezu kwaseminyakeni edlule, okudale ukuthi kube nocwaningomabhuku oluyisishiyagalombili olungaqedwanga ngesikhathi embikweni jikelele we-AG. Phezu kwalokho, babe bathathu omasipala abathole imibono engenamiphumela. Lokhu kusho ukuthi cishe uhhafu womasipala baseFree State awukachazi ngendlela abasebenzise ngayo imali yabakhohintela ngonyaka wezi-2018-19 noma lokho bakwenze ngendlela enganelisi kangangoba izitatinende zezimali zabo azithembakali.

Imiphumela ibonakala ngokusilela kwezindlela zokuphathwa kwezimali eziyisisekelo, ukungathandi ukulandela umthetho, nokungazigqizi qakala nhlobo izindlela zokulawula nezesibophokubika.

Ukusetshenzisa okungajwayelekile kwesifundazwe kube yizigididi ezingu-R1,4 ngonyaka obuyekezwayo. Ezinye izigidi ezingu-R341,6 zezindleko ezingajwayelekile zabonakala kucwaningomabhuku olwaqedwa kulandela usuku olwaluwumnqamulajuqu walo mbiko.


Isifundazwe sisebenzise izigidi ezingu-R46 sezizonke ngezindleko zokwelulekwa wochwepheshe ababesiza ngokubika ngesimo sezimali, yize lokhu kwaba nomthelela omncane eqophelweni lezitativende zezimali ezathunyelelwa ucwaningomabhuku. Kulokhu, izigidi ezingu-R17 zasetshenzisa omasipala okwakungakaqedwa ucwaningomabhuku lwazo ngosuku olwaluwumnqamulajuqu walo mbiko. Ukungadluliswa kwamakhono ochwepheshe edluliselwa komasipala kubonakale ngokuthi abanye abasebenzi babengakwazi nokuhlinzeka ngolwazi lwezimali oluyisisekelo ngaphandle kosizo lochwepheshe.

### EGauteng

Isimo saseGauteng sibe nozinzo ngokuthi bonke omasipala baphinde bayigcina imiphumela yocwaningomabhuku emihle yabo. Kube yilesi kuperha isifundazwe omasipala baso bonke abathole imibono yocwaningomabhuku olungenasici, kodwa njengaseminyakeni edlule kube yi-Midvaal kuperha ethole umbiko wocwaningomabhuku onesici. Lokhu kuqhubelekile nokugwemeka kwabanye omasipala ngenxa yokubalwa kwezimali okuhle kodwa kunokungaziqaphi ngokwanele izindlela zokulawula ezidingekayo ukuqinisekisa ukulandelwa komthetho nokubika ngempumelelo yokuhlinzeka ngemisebenzi.

Omasipala abaqashe nabagcine abasebenzi abanamakhono afanele bazuzile ngalolu zinzo futhi bakwazi ukuthola imiphumela emihle yocwaningomabhuku. Kolunye uhlangothi, omasipala ababonakale benganalo uzinzo kwezepolitiki noma kwezobuholi bezokuphathwa kwemisebenzi, njengakomasipala abakhulu base-City of Tshwane nase-City of Johannesburg, abakwazanga ukuthuthukisa imiphumela yabo.

Izindleko ezingajwayelekile kulesi sifundazwe zibe yizigididi ezingu-R1,7 komasipala. Kubikwe nangezinye izigididi ezingu-R3,3 zakucwaningomabhuku olwaqedwa kulandela usuku olwaluwumnqamulajuqu walo mbiko, lapho umasipala omkhulu i-City of Tshwane, yabalelwa izigididi ezingu-R2.9 kule mali bese i-Emfuleni yaba yizigidi ezingu-R358.

Isikhungo zomasipala zakulesi sifundazwe zibe ngezindleko ezingajwayelekile ezingu-R1.8 ngesikhathi esibuyekezwayo.





### KwaZulu-Natali

Kube noshintsho oluncane emiphumeleni yocwaningomabhuku esifundazweni, asigcinwanga isibophokubika ngokufanele futhi ubuholi abuzange busiphoqelele, futhi kuqhubelekile nokwahluleka kwezindlela zokulawula ezisemqoka.

Omasipala besifunda abanangi baqhubelekile nokuhluleka ukuba nezinquo eziyisisekelo zezimali nezokuphathwa komsebenzi, baveza ukungasukumi baqalise futhi baqaphe izinhlelo, futhi babe nezinhlelo zokuphatha ezintengantengayo ezenze ukuthi bangakwazi ukugcina isibophokubika ngempumelelo.

Ubuholi bebungahlali buba nomthelela ezinhlelweni ezinamandla zokulawula zangaphakathi ukuhola ukubusa okuhle nokulandelwa kwezimis - kugxilwe kakhulu ekwenzeni umsebenzi wokuqapha ngokwezepolitiki nokubhekana nezifiso zezakhamizi.

Umthelela walokhu ubonakale ngokwanda kwezindleko ezingajwayelekile, okubikwe ukuthi kube yizigididi ezingu-R6,5 ngesikhathi esibuyekezwayo, uMasipala Omkhulu waseThekwini waba nezigididi ezingu-R2,34 kule mali. Ezinye izigidi ezingu-R17,2 zezindleko ezingajwayelekile zisuselwe kucwaningomabhuku olwaqedwa kulandela usuku olwaluwumnqamulajuqu walo mbiko.


Kuqhutshekiwe nokusetshenziswa kochwepheshe ezimweni eziningi ukusiza ukulungisa izitativende zezimali nokubika ngesimo sezimali, isifundazwe sasebenzisa izigidi ezingu-R95 kulokhu; kube abasebenzi bebekhona abaqashelwe le misebenzi. Kulokhu, sibe sinye isigidi samarandi esasetshenziswa omasipala okwakungakaqedwa ucwaningomabhuku lwazo ngosuku olwaluwumnqamulajuqu walo mbiko.

Bayisithupha omasipala esifundazweni abathuthukile emiphumeleni yocwaningomabhuku bese abathathu behla. Lokhu kuthuthuka kusizwe kakhulu wukubonisana nochwepheshe, kodwa yize isifundazwe sisebenzise izigidi ezingu-R249 ngochwepheshe ngezinhloso zokubika ngezimali, omasipala abanangi baqhubelekile nokuthola imibiko enesici. Kulokhu, izigidi ezingu-R127 zasetshenziswa omasipala okwakungakaqedwa ucwaningomabhuku lwazo ngosuku olwaluwumngamulajuqu walo mbiko.

Kube nokwethembela kochwepheshe okukhulu, amakhono akadlulismwanga, futhi abanye abasebenzi baye banethezeka uma kuqokwa ochwepheshe bese bangasayenza imisebenzi abayiqashelwe, okudale imibuzo ngomasipala abaholela abasebenzi nochwepheshe ukuze benze umsebenzi owodwa. Kusetshenziswe izigidi ukuthuthukisa imiphumela, kodwa akubanga nazijeziso ngokungasebenzi kahle.

Umthelela wokulahlekelwa yizigidigli ezingu-R1,2 emuva kokuwa kwe-VBS Mutual Bank kusazwela komasipala abathintekayo, lapho kuthinteke ukuhlinzeka ngemisebenzi.


Ukusetshenziswa okungajwayelekile kwesifundazwe kube yizigidigli ezingu-R1,5 ngonyaka obuyekezwayo. Kubikwe ngezinye izigidi ezingu-R594 zezindleko ezingajwayelekile zisuselwe kucwaningomabhuku olwaqedwa kulandela usuku olwaluwumnqamulajuqu walo mbiko.

## EMpumalanga

Ukwehla kwezinga lesibophokubika nokuphatha kwezimali kuhambisana nokuqapha okuntengantengayo kuwumnyombo wokwehla okukhulu kwemiphumela yocwaningomabhuku esifundazweni - bayisithupha omasipala abehlile bese baba babili kuphela abathuthukile. Kube nokwehla kwezindlela zokulawula kwinqwaba yomasipala, obekubandakanya izindlela zokuphathwa kwezimali eziyisisekelo njengokugcinwa kwamarekhodi, ukudidiyela nokuqinisekisa.

Babe babili kuphela omasipala abasebenzise ochwepheshe ukuthuthukisa imiphumela yabo yocwaningomabhuku yize ochwepheshe besetshenziselwe ukwenza umsebenzi wabasebenzi abaqashiwe. Isifundazwe sasebenzisa izigidi eziyi-R98 ngezindleko zokwelulekwa wochwepheshe maqondana nokubika ngezezimali. Kulokhu, izigidi ezingu-R3 zasetshenziswa omasipala okwakungakaqedwa ucwaningomabhuku lwazo ngosuku olwaluwumnqamulajuqu walo mbiko.

Umkhuba wokusebenzisa izibonelelo ezinemigoqo ngokungaphansi kwezinga elifanele kuveza ukusilela kwezokuhlela komasipala - kube nemali eyizigidi ezingu-R154,4 ezisetshenziswe ngokungaphansi kwezinga elifanele.



Onyakeni obuyekezwayo, omasipala besifundazwe babe nezindleko ezingajwayelekile ezifinyelela kuzigidi ezingu-R390.

Isifundazwe sasebenzisa izigidi eziyi-R47 ngezindleko zokwelulekwa wochwepheshe maqondana nokubika ngezezimali. Kule mali, yizigidi ezingu-R12 ezhambisana nocwaningomabhuku oluqedwe kulandela usuku olwaluwumnqamulajuqu walo mbiko.



## ENyakatho Ntshonalanga

Ukwehla kwemiphumela yocwaningomabhuku kuqeda iminyaka emithathu kulandelana esifundazweni: omasipala abayisishiyagalolunye bathole imibiko engenamiphumela bese abayisishiyagalombili bathola imibono enesici. Ukutholakala kwemibhalo noma ubufakazi bokweseka okwenziwa ngemali kusayinselele enku lu komasipala, njengoba kubonakele ngesibalo esiphindayo semibono engenamiphumela. Ukuhlulekka kwesifundazwe ukushintsha lo mkhuba wemiphumela yocwaningomabhuku enemiphumela emibi kuveza usiko lokungazithathi kuqala izinyathelo zokubhekana nezindlela zokulawula ezintengantengayo ezavezwa eminyakeni edlule.

Ukuhluleka ukugcina isibophokubika kwabaphathi abakhulu, abaphathi bomasipala, osodolobha, amaphiko ocwaningomabhuku angaphakathi, amakomidi ocwaningomabhuku, amakomidi ama-akhawunti kahulumeni kamasipala kanye nemikhandlu kuveza ukuhluleka kwezinhlelo emkhakheni wezokulawulwa kwezimali.

Onyakeni obuyekezwayo, omasipala besifundazwe babe nezindleko ezingajwayelekile ezifinyelela kuzigididi ezingu-R3.7, ezinye izigididi ezingu-R1,8 zisuselwe kucwaningomabhuku olwaqedwa kulandela usuku olwaluwumnqamulajuqu walo mbiko.


Izindleko zokusebenzisa ochwepheshe zifinyelele kuzigididi ezingu-R227 ngokubika ngezezimali, kube omasipala bebebaholela abasebenzi babo kanye nochwepheshe ngokwenza umsebenzi owodwa kube kungekho mphumela obonakalayo futhi okudale ukulahlwa kwezinsiza zikakhulumeni ezivele zishoda. ### ENtshonalanga Kapa

Isibalo esikhulu socwaningomabhuku olungenasici lusase Ntshonalanga Kapa (45%), kube ama-93% omasipala besifundazwe bathole imibono engenasici ezitatinendeni zezimali zabo. Omasipala abayisishiyagalombili bagcine isimo sabo socwaningomabhuku olungenagcobho - abayisithupha bagcine isimo sabo iminyaka emihlanu edlule noma ngaphezulu.

Omasipala abagcine imiphumela yabo engenagcobho babonakala ngezindlela zokulawula ezibhaliwe ezi setshenziswayo, ezivikelayo ngokwazo

neziphogelelwā ngokuqinisa isandla kwabaholi. Lokhu kubandakanya izindlela zokulawula ukusebenza ezibhaliwe nezisetshenziswayo ezinhlelwēni zabo ezingancikile kumuntu nomuntu, ezisho ukuthi isibalo sabasebenzi angeke siholele ekuhlelekeni kokusebenza kwezindlela zokulawula. Phezu kwalokho, abaphathi abayamukeli kalula imiphumela yocwaningomabhuku futhi kunezinga eliphezulu lokugcina isibophokubika; futhi bonke abahlinzeki beziqiniseko bayawazi amaqhaza abo futhi benza owabo umsebenzi kwezokulawula.

Izitativende zezimali zivame ukuhambisana nesimo senhlalomnotho somasipala ngamunye kanye nokuhlola kwe-AGSA kwezinhlelo zezimali. Omasipala abanangi bahlulekile ukuqoqa izikweletu zabo, kodwa lilonke isimo sezimali somasipala baseNtshonalanga Kapa yiso esibe sihle kunabo bonke omasipala.

Onyakeni obuyekezwayo, omasipala besifundazwe babe nezindleko ezingajwayelekile ezifinyelela kuzigidi ezingu-R2,7.



## **Ukwehla kwemiphumela yocwaningomabhuku isiyonke**

Kuphinde kwaba nokwehla kwemiphumela yocwaningomabhuku ngaphansi kwabaphathi bemisebenzi yohulumeni basekhaya bamanje, manje sekuwunyaka wawo wesithathu. Esikhathini seminyaka emithathu, imiphumela yocwaningomabhuku lomasipala angama-76 yehlile kwaba ngengama-31 kuphela ethuthukayo.

Ukuntengantenga okukhulu ekuphathweni kwezezimali kohulumeni basekhaya okulandelayo bekungadingidwanga eminyakeni emithathu edlule:

### **Iqophelo elibi lezitativende zezimali ezithunyelwe nemibiko yokwenziwa komsebenzi**

UMakwetu uchaza ukuthi izitativende zezimali ezifanele kanye nemibiko yokusebenza kubalulekile ukuze kube nesibophokubika nokuvuleleka kuhulumeni. Uveze ukuthi omasipala abanangi baqhubeleka nokuhluleka kule mikhakha.

Uthe: "Imibono engenasici ezitativendeni zezimali ayizange igcine ngokwehla isuka kuma-47% iya kuma-43%, kodwa iqophelo lezitativende zezimali esihlinzekwe ngazo zocwaningomabhuku alibanga nokuthuthuka kunangonyaka odlule. Ama-18% kuphela omasipala abakwaze ukusinika izitativende zezimali ngaphandle kokubhala okungasilo iqiniso okukhulu."

U-AG ungezele wathi imibiko yokwenziwa komsebenzi yama-67% omasipala abathumele imibiko ebeyinamaphutha amakhulu futhi ebeyingalungele ukusetshenziswa umkhandlu noma umphakathi.

## **Ukuvama kokusetshenziswa kochwepheshe kuba nemiphumela emincane ebilindelekile**

Omasipala basebenzise izigidigidi ezingu-R1,26 ngochwepheshe bemisebenzi yezokubika ngezimali, kube ama-7% alokho adalwe yizikhala zomsebenzi ezikhona kumaphiko ezezimali akomasipala. Le mali ibandakanya izigidi ezingama-R522 zezindleko zokubonisana nochwepheshe ngocwaningomabhuku olusilele lapho kutholakale khona izitativende zezimali. Bangama-14% kuperha omasipala abasebenzise ochwepheshe ababonakalise ukuthuthuka kwemiphumela yabo yocwaningomabhuku, kube ama-22% ehlile.

## **Isimo sezimali somasipala siyakhathaza futhi sidinga ukuthi kungenelelwwe ngokushesha**

Izitativende zezimali ziveza ukwanda kwezimpawu zokuwohloka kwezimali zohulumeni basekhaya - i-AGSA ihlole omasipala abangama-79% abanesimo sezimali ebesikhathaza noma sidinga ukuthi kungenelelwwe ngokushesha. Bangaphansi kokukodwa kokuthathu omasipala abasesimweni sezimali esintengantengayo.

“Ukwahluleka ukuqoqa isikweletu samakhasimende kamasipala kuye kwanda. Kulezi zimo, bayingekho indlela yokuthi omasipala bangabhekani nobunzima bokubhalansisa amabhuku. Sebebonke, bangama-34% omasipala abadalule ukushoda kwemali (ngamanye amazwi izindleko zeqe ingeniso) - ukushoda kwemali sekukonke kulabo masipala kube yizigidigidi ezingu-R6,29.

“Izinkinga zezimali zohulumeni basekhaya ziphinde zabaxaka kakhulu abakweletwa imali womasipala. Isikhathi sokukhokhelwa kwabakweletwayo esivamile siyizinsuku ezingama-180. Ekupheleni konyaka, omasipala

bebekweleta izigidigidi ezingu-R53,52 kodwa imali ebikhona beyiyizigidigidi ezingu-R43,20. Imali eyayikweletwa u-Eskom ekupheleni konyaka yayisilele ngezigidigidi ezingu-R11,31, okuthe izigidigidi ezingu-R9,02 beseyivele idlulelw isikhathi sokukhokhwa ngezinsuku ezingaphezu kwama-120. Amabhodi amanzi nawo ayahluleka ukuqoqa imale ekweletwa omasipala - amakhawunti abo abesemuva ngokukhokha ngemali eyizigididi ezingu-R6,24, okuthe izigidigidi ezingu-R5,38 kuyo besezidlulelw isikhathi ngezinsuku ezingama-120," kusho u-AG.

Uthi njengoba isimo somnotho esibi sinesandla ekuwohlokeni kwesimo sezimali somasipala, abanigi abaziphathi izimo zezimali zabo njengoba kufanele.

### **Ukunyuka kwezindleko ezingenanzozo neziwukusaphaza**

UMakwetu uthe uhulumeni angeke akwazi ukulahlekelwa imali ngenxa yokuthathwa kwezinqubo ngendlela engeyiyo, ubudedengu noma ukungagculisi. Nokho, ihhovisi locwaningomabhuku liqhubekile nokubona ukukhuphuka kokusetshenziswa kwemali ngendlela engenanzozo nokusaphazwa kwayo, kwathi omasipala abangama-200 balahlekelwa izigidigidi ezingu-R2,07 kulo nyaka. Esikhathini seminyaka emithathu, izigidigidi ezi-R4,27 zezindleko zikahulumeni zaba ngeziwukusetshenziswa kwemali okungenanzozo nokusaphaza.

### **Izinga eliphezulu kakhulu lokungalandelwa kwezimiso zemithetho yokuphatha**

Sebebonke, bangama-91% omasipala abangazange bawulandele umthetho. Umphumela uyefana nowangonyaka odlule futhi ukhuphuke kancane kuama-85% angowezi-2016-17. Ukungabibikho kokuqapha nokulawula kwezokulandelwa kwezimiso kubonakele ezindaweni eziningi, okubandakanya ukuphathwa kokukhishwa kwezinkontileka zemisebenzi.

## **Ukwehla kokulandelwa kwezimiso zomthetho wokukhishwa kwezinkontileka zemisebenzi**

Ukulandelwa kwezimiso zomthetho wokukhishwa kwezinkontileka zemisebenzi kwehlile kusukela ngowezi-2016-17. U-AG usakhathazekile ngokuthi ama-2% kuphela omasipala alandela izimiso ngokugcwele. \*Lokhu kwenzeka yize kunenqwaba yemibiko esayenza ngalolu daba, sahiveza izimo ezingaba nobungozi, kanye nenqwaba yezincomo esazenza. Izinqubo ezingancintisani nezingalungile kanye nokuphathwa ngokungafanele kwezinkontileka kuye kwavama," kuchaza uMakwetu.

## **Ukwanda kwezindleko ezingajwayelekile**

Izindleko ezingajwayelekile zikhuphukele kuzigididi ezingu-R32,06 kusuka kuzigididi ezingu-R25,2 ezibikwe ngonyaka odlule. Kubandakanya izindleko ezingajwayelekile (izigididi ezingu-R10,60) zalabo masipala abanocwaningomabhuku oluqedwe ngemuva kosuku oluwumnaqamulajuqu lwalo mbiko (31 Januwari) kanye nezimali ezingadlulanga kucwaningomabhuku ezidalulwe ezitativendeni zezimali zomasipala abanocwaningomabhuku olusasilele.

U-AG uxwayise ngokuthi imali beyingaba ngaphezu kwalokhu, njengoba zingama-55% izikhungo okucwaningwe amabhuku azo okutholakale zinocwaningomabhuku olunezici ngoba imali eyadalulwa beyingaphelele futhi/noma zadalu ukuthi zibe nezindleko ezingajwayelekile kodwa inani eliphelele lingaziwa. Phezu kwalokho, inani lezinkontileka eliyizigididi ezingu-R0,36 alikwazanga ukudlula kucwaningomabhuku ngenxa yolwazi olushodayo noma olungaphelele.

Omasipala banamabhuku abo anomlando ongemuhle wokubhekana nezindleko ezingajwayelekile nokuqinisekisa isibophokubika.. Ngenxa yalokho,

ibhalansi yokuphela konyaka yezindleko ezingajwayelekile ebeseziqongelekile eminyakeni eminingi nokungabhekanwanga nazo (ngokuqoqwa, ukudluliswa noma ukusulwa) ziyyigidigidi ezingu-R65,59.

### **Ukusilela ekuthuthukisweni nasekulungisweni kwengqalasizinda**

Ucwaningomabhuku lumphinde lahlonda inqwaba yokusilela ekuthuthukisweni nasekulungisweni kwengqalasizinda. Imisebenzi yokuthuthukiswa kwengqalasizinda iveze ukwanda kokusetshenziswa kwemali engaphansi kwaleyo ekusabelomali, ukubambezeleka kokuqedwa kwayo, ukungalandelwa komthetho wokukhishwa kwezinkontileka zemisebenzi, nezindleko ezingajwayelekile.

Okukhathaza kakhulu, kusho u-AG, wukunganakwa kwengqalasizinda yamanzi neyokuthuthwa kwemfucuza - isimo samanzi kanye/noma sengqalasizinda yemfucuza besingahlolwa komasipala abangaphezu kokukodwa kokuthathu abanomsebenzi wokwenza lokho; futhi ama-41% omasipala abengenazo izinqubomgomu zokulungisa impahla. "Akumangazi, ukuthi ama-36% omasipala abanomsebenzi wokuhlinzeka ngamanzi nengqalasizinda ukuthi baveze ukulahlekelwa ngamanzi okungaphezu kwama-30%. Ukulahlekelwa ngamanzi sekukonke okudaluliwe kube yiyyigidigidi ezingu-R6,56," kuchaza u-AG

Ukulungiswa kwemigwaqo akubonisanga ukuthuthuka, kodwa ama-27% omasipala akazange asungule noma aqalise izinhlelo zokulungisa umgwaqo ezigunyaziwe zokuvuselelwa nokulungiswa ngezikhathi nezikhathi, kube ukusilela kokuvuselela nokulungisa kwezikhathi nezikhathi kuqhube kwaba kuma-16% komasipala.

## **Isigaba sokuqala sokuqalisa amandla ka-AG angeziwe**

Amandla angeziwe ka-AG aqala ukusebenza mhla lu-1 Ephreli 2019, futhi i-AGSA yaqala ukuqalisa izinqubo zokungajwayelekile okukhulu komasipala abayisishiyagalolunye ababekhethiwe. Lwaba yisithupha kulokhu ucwaningomabhuku olwaqedwa ngosuku lombiko wohulumeni basekhaya. Obekugxilwe kukho onyakeni obuyekezwayo kube wukungalandelwa komthetho okudale, noma okungase kudale, ukulahlekelwa yimali okukhulu.

Kwaba nokungajwayelekile okukhulu okuyisithupha okwahlonzwa komasipala abathathu, okwadala ukuhlahlekelwa yimali okungu-R24 499 866 sekukonke. Izi-R2 421 897 zaziwa ngokuthi ukulahlekelwa okuqondene nomphathi kamasipala, njengoba okusele kuwukulahlekelwa okuqaguliwe. Okungajwayelekile okukhulu kakhulu (okuthathu) kwahlonda kumasipala wesifunda iNgaka Modiri Molema eNyakatho Ntshonalanga.

Uthi u-AG, "Okungajwayelekile okukhulu esakuhlonza futhi sabika ngakho akusikho ukubala okudidayo noma izinkinga zokukhishwa kwezinkontileka zemisebenzi futhi bekungagwemeka ngezindlela zokulawula eziyisisekelo. Kuhambisana nokungagadwa kwempahla okudale ukwebiwa noma ukulinyazwa kwayo, ukukhokhelwa kwempahla nemisebenzi eyenziwe, kanye nezinqubo zokukhishwa kwezinkontileka zemisebenzi ezingalungile okudale ukunyuswa kwamanani.

"Abaphathi bomasipala bakhombisa ukuzwa uma beziswa ngokungajwayelekile okukhulu esakuhlonza, futhi iningi labo lithatha isinyathelo ezifanele ukubhekana nalokhu. Lokhu kuveza ukuthi bayakuqonda okudingeka bakwenze ngokomthetho uma bethola ulwazi ngokungajwayelekile futhi bazimisele ngokuthwala le mithwalo. Kuphinde kube yiphathu lokushintsha kwendlela yokuziphatha maqondana

nokubhekana nemiphumela esiyitholile ngendlela yokuthatha izinqumo ezifanale nangesikhathi esifanele."

## **Isiphetho**

U-AG uphethe ngokuthi, "Uma sibheka yonke indawo nangemuva kokucubungulisa izitativende zezimali esenze ucwaningomabhuku kuzo, singasho singanqikazi ukuthi ohulumeni basekhaya banayo imali eyanele kanye nempahla yokugcwalisa iningi lezidingo eziyisisekelo kanye nokufiswa izakhamuzi zabo. Kodwa muningi umsebenzi odingekayo ukuqinisekisa ukuthi lokhu kuyenzeka. Ukuphathwa komsebenzi ngokufanele nokuqapha izimo zezimali zohulumeni basekhaya akwenziwanga futhi akutholakalanga, ngalokhu kuhlola kocwaningomabhuku, ukuze kungabi nokusilela okukhulu okunemiphumela ebucayi eseyibonakala kweminye imikhakha ehlonzwiwe."

### **Ukuqalisa izindlela zokulawula zokuthuthukisa isimo esikhathazayo**

UMakwetu uthi izindlela zokuvikela zizokwenza umsebenzi omkhulu ukungelela esimweni samagebhe akhona ekuphatheni kanye nokuntengantenga okubalulwe embikweni wakhe.

Izindlela zokulawula ziyizindlela zokuvikela, imithetho nezinqubo eziqaliswa umasipala ukuqinisekisa ukuthi ubuqotho bolwazi lwezezimali nezokubala, ukukhuthaza isibophokubika, kanye nokuvikela ukukhwabanisa nephutha. Ngaphandle kokulandela umthetho, ukuvikela impahla yesikhungo ekwebiweni noma ukugwema imisebenzi yokukhwabanisa, izindlela zokuvikela zingasiza ukwandisa impumelelo yokusebenza ngokuthuthukisa ukubika ngesimo sezimali okuyikho nokwenziwa ngesikhathi.

"Ukunqanda izitativende zezimali nemibiko yokwenziwa kwemisebenzi okusezingeni eliphansi, ukungalandelwa kwezimiso kanye nokungajwayelekile okukhulu kunomthelela omkhulu kunokubhekana nokujezisa ngakho - kulahleka imali nesikhathi, kumele kwenziwe uphenyo olubizayo, futhi abasebenzi baba nokungakhululeki nexhala elihambisana nalezi zinqubo, okuvame ukudonsa iminyaka".
